Thank-you for you interest in the Marian and Me product. We are committed to our customers, and to providing them with the highest quality product and service. To place an order you must be a licensed retailer.

**REQUIREMENTS:**

- (1) Please complete our wholesale application fax , mail or e-mail it along with a copy of your business license or resale certificate.
- (2) A photocopy of your Federal Tax Identification No.
- (3) If you are a web-based business online store provide proof of domain registration.
- (4) A valid e-mail

**ORDERS AND MINIMUMS:**

- (1) Your opening order must be a minimum of \$250.00
- (2) Re-orders must be a minimum of \$100.00.
- (3) All products are ordered in inner pack quantity - 6 pc pack (not individually).
- (4) New accounts initial orders will be paid by credit card (see terms)
- (5) Orders being paid by credit cards will be charged when the order is shipping that day.

**BACKORDERS:**

- (1) **Items in stock will be shipped within 3 business days. All backorders will take 3 weeks.**  
There will no charge for shipping on backorders. The customer can request to cancel those items.

**PAYMENT & CREDIT:**

- (1) Credit Cards are accepted for prepayment: Visa, Mastercard and Discover .
- (2) Terms are Net 30 days for credit approved accounts.
- (3) Interest will be charged for past-due accounts.
- (4) Returned checks - will be charged a \$30.00 processing fee and will result in your account being prepaid.
- (5) Refunds will be minus the shipping cost.
- (6) C.O.D. Certified check

**SHIPPING:**

- (1) Standard shipping is via UPS ground, unless otherwise stated at the time of ordering.
- (2) UPS one, two and three-day are available. **Fed-ex also available.**
- (3) Shipping and handling are FOB Cranston ,Rhode Island
- (4) **All packages insured totally \$100.00 or more.**

**RETURNS:**
